

up to 09/10/23 till 11:00 AM at Room No. 06, Ground Floor Yojana Bhawan and its bid shall not be opened. The Demand Draft for RISL Processing Fee in favor of "Managing Director, RajCOMP Info Services Ltd." payable at "Jaipur" from any Scheduled Commercial Bank.

- 3) To participate in online bidding process, Bidder must procure a Digital Signature Certificate (Type III) as per Information Technology Act-2000 using which they can digitally sign their electronic Bid. Bidders can procure the same from any CCA approved certifying agency, i.e. TCS, Safecrypt, NCODE etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC. Also, bidder must register on <http://eproc.rajasthan.gov.in> (bidder already registered on <http://eproc.rajasthan.gov.in> before 08-10-2023 must register again).
- 4) RISL will not be responsible for delay in online submission due to any reason. For this, bidder is requested to upload the complete bid well advance in time so as to avoid 15:00 hour issues like slow speed, choking of web site due to heavy load or any other unforeseen problems.
- 5) Bidder is also advised to refer "Bidder Manual Kit" available at e-Procurement website for further details about the e-Tendering process.
- 6) Training for the bidder on the usage of e-Tendering System (e-Procurement) is also being arranged by RISL on a regular basis.
