   However, DD for Tender Fees, RISL Processing Fees, and Bid Security should be submitted physically at the office of Tendering
   Authority as prescribed in NIB and scanned copy of same should also be uploaded along with the technical Bid/cover.
- 2) \* In case, any of the bidders fail to physically submit the Banker's Cheque/ Demand Draft for Tender Fee, Bid Security, and RISL Processing Fees mention in NIT/NIB, its Bid shall not be accepted. The Banker's Cheque/ Demand Draft for Bidding document fee, RISL Processing Fee and Bid Security should be drawn in favour of 'Managing Director, RajCOMP Info Services Ltd.' payable at 'Jaipur' from any Scheduled Commercial Bank.
- 3) To participate in the online bidding process, Bidders must procure a Digital Signature Certificate (Type III) as per Information Technology Act-2000 using which they can digitally sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency, i.e., TCS, Safe crypt, Ncode, etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC. Also, bidders must register on http://eproc.rajasthan.gov.in (bidders already registered on http://eproc.rajasthan.gov.in before 30-09-2011 must register again).
- 4) RISL will not be responsible for delay in online submission due to any reason. For this, bidders are requested to upload the complete bid well advance in time so as to avoid 11th-hour issues like slow speed; choking of the website due to heavy load or any other unforeseen problems.
- 5) Bidders are also advised to refer 'Bidders Manual Kit' available at e-Procurement website for further details about the e-Tendering process.
- 6) Training for the bidders on the usage of e-Tendering System (e-Procurement) is also being arranged by RISL, on a regular basis.
